When applying for a Residence Permit, the applicant shall pay:

- state fee in the amount of 2 non-taxable minimum of personal incomes;
- administrative service fee for issuing a Residence Permit;
- administrative service fee for issuing a Residence Permit in Ukraine;
- bank fee.

The total fees for a Residence Permit at the Passport Service, SE will be UAH 2,533. In addition to these fees, our lawyers charge a service price for assistance in obtaining a Residence Permit.

What do you need to prepare for obtaining a Temporary Residence Permit?

The applicant must prepare a number of documents which also involve explicit costs.

For example:

- translation of the foreign passport into Ukrainian certified by a notary;
- health insurance policy for 1 year;
- other documents.
