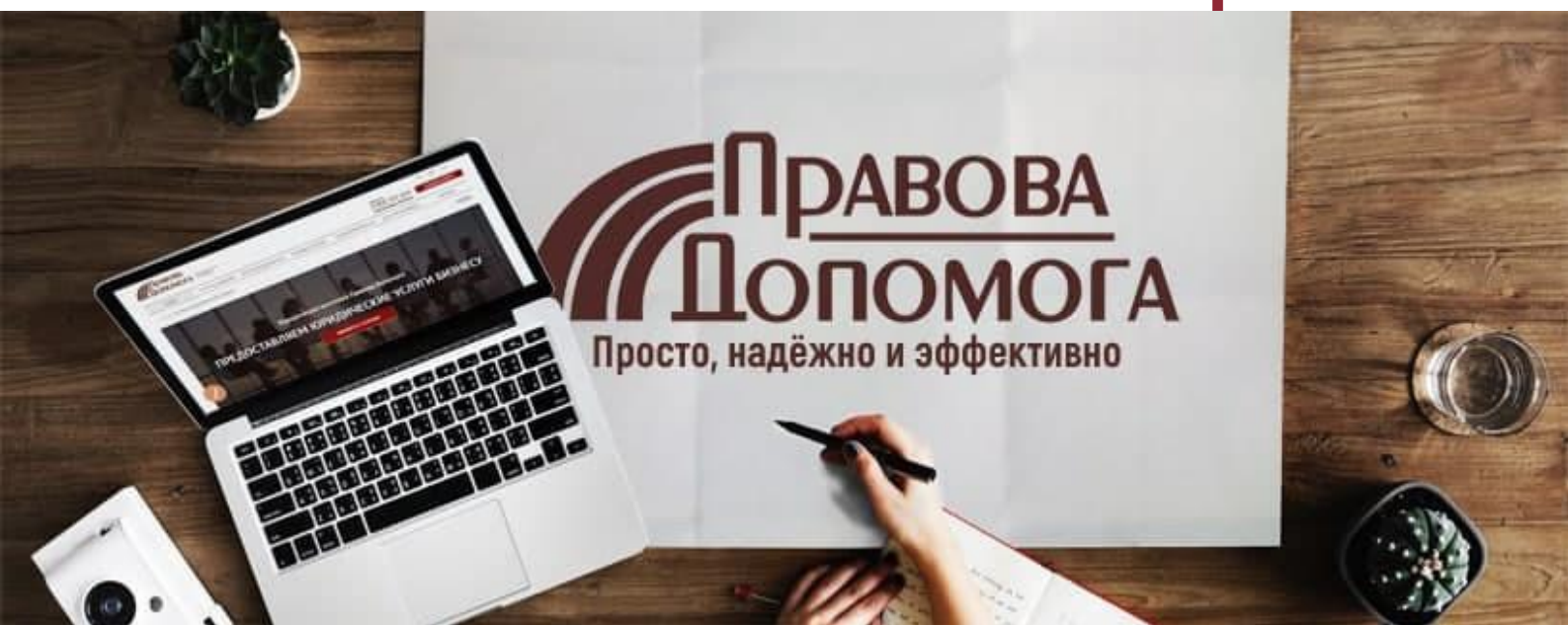

# MUCH MORE THAN LEGAL ADVICE

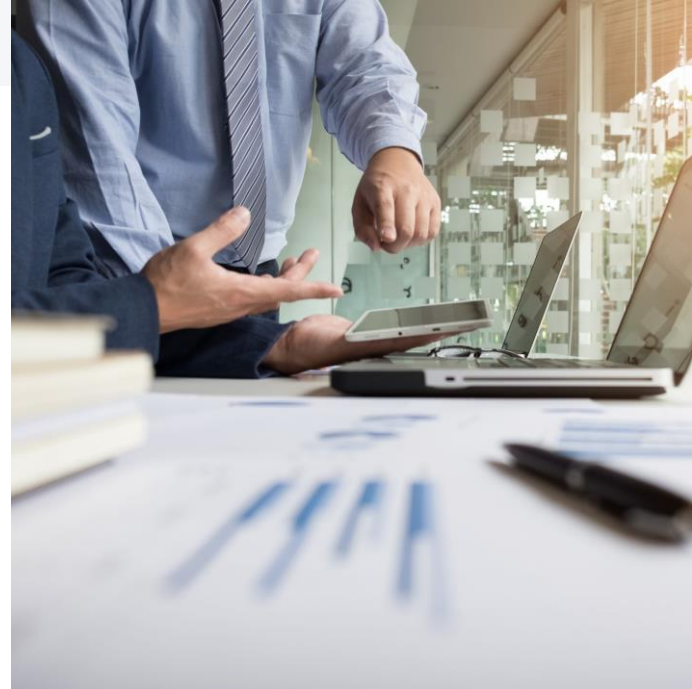
